Greenwood Township Board of Trustees

Monthly Meeting Minutes

Supervisor Barbara Klasen called the monthly meeting of the Greenwood Township Board of Trustees to order at 7:30pm followed by the Pledge of Allegiance.

Board Members Present: Trustee Tim Stefaniak, Trustee Christopher Dahm , Trustee Karin Swencki, and Trustee Charles Beard .

Other Members Present: Bookkeeper Colleen Dumais, Supervisor Barb Klasen, Assessor Karen Roth, Deputy Assessor Randall Roth, and Clerk Kendra Rishling.

Approval of Township and Road District Bills: Motion to approve the Township and Road District Bills by Charles Beard and seconded by Christopher Dahm. By roll call vote, all in favor said aye. Motion Carried.

Assessor's Report: Assessor Karen Roth stated that reassessments are started and they are looking at Sunrise Ridge and Highland Shores currently. Farms are on hold for reassessment at this time. Karen stated that their office is concentrating on making the neighborhoods more uniform by using good recent sales.

Audience Questions/Comments: No questions. No audience present.

Supervisor's Report: Supervisor Barb Klasen reviewed the statistics for the Township Website and how many hits in different categories as found by Jon Toussaint who is managing the website.

Supervisor Barb Klasen stated that she is going to do a budget comparison to review at the next Board Meeting on the amounts paid out through General Assistance.

Supervisor Barb Klasen requested a motion to approve to pay a Chase credit card expense for Township Education Expenses in the amount of 242 dollars. Motion to

approve by Tim Stefaniak and seconded by Karin Swencki. All in favor said aye by roll call vote. Motion carried.

Road Commissioner's Report: Highway Commissioner Don Goad not present. Bookkeeper Colleen Dumais relayed Highway Commissioner Don Goad's report. Bookkeeper Colleen Dumais presented to Board that Highway Commissioner Don Goad is going to purchase two filing cabinets from company Health Insurance Specialists for 100 dollars and that he wants to prepay for LP Gas from Conserve FS for 7000 dollars to see the Township through winter. Bookkeeper Colleen Dumais stated that it was the Highway Commissioners intent to advise the Board of these expenses.

Bookkeeper's Report: Bookkeeper Colleen Dumais reviewed monthly expense/income reports. Christopher Dahm addressed that the traffic tickets in the Township were accidentally going to Mchenry Township. Chris requested this be looked into because he spoke to someone at the Clerk of the Circuit Court's Office and they said that a computer glitch was to blame. Supervisor Barb Klasen will look into where the money from the tickets is being allocated.
