Monthly Meeting Minutes

August 15th, 2011

Supervisor Barbara Klasen called the monthly meeting of the Greenwood Township Board of Trustees to order at 7:40 p.m. followed by the Pledge of Allegiance.

Board Members Present: Trustee Christopher Dahm, Tim Stefaniak, Karin Swencki and Trustee Charles Beard .

Other Members Present: Supervisor Barb Klasen, Highway Commissioner Don Goad, Bookkeeper Colleen Dumais, Assessor Karen Roth, and Clerk Kendra Rishling.

Approval of Meeting Minutes: Christopher Dahm motioned and seconded by Karin Swencki to approve the monthly meeting minutes as recorded for July 18th. Motion carried.

Approval of Township and Road District Bills: Motion to approve the Township and Road District Bills by Christopher Dahm and seconded by Tim Stefaniak. By roll call vote, all in favor said aye. Motion Carried.
