Monthly Meeting Minutes

October 17th, 2011

Supervisor Barbara Klasen called the monthly meeting of the Greenwood Township Board of Trustees to order at 7:39 p.m. followed by the Pledge of Allegiance.

**Board Members Present:** Trustees Christopher Dahm, Tim Stefaniak, and Trustee Charles Beard .

**Other Members Present:** Supervisor Barb Klasen, Deputy Assessor Randall Roth, Bookkeeper Colleen Dumais, and Clerk Kendra Rishling.

**Approval of Meeting Minutes:** Christopher Dahm motioned and seconded by Charles Beard seconded to approve the minutes with the correction to remove the “near McHenry County College” on page two line 6 and the rest of the monthly meeting minutes as recorded for September 19<sup>th</sup>,2011. Motion carried.

**Approval of Township and Road District Bills:** Motion to approve the Township and Road District Bills by Christopher Dahm and seconded by Tim Stefaniak . By roll call vote, all in favor said aye. Motion Carried.

**Assessor’s Report:** Deputy Assessor Randall Roth stated that the appeals are underway and that there are approximately 300. Hearings are being scheduled for some properties now.

**Audience Questions/Comments:** No questions from audience.

**Old Business:** Supervisor Barb Klasen reviewed that the Senior transportation program will go forward for review on this Wednesday. If approved, it should be underway starting in November.

**New Business:** Supervisor Barb Klasen presented the letter of recommendation from Chairman Mike McCleary from the Township Planning Commission Board to appoint Ron Zieman to the vacancy on the Township’s Planning Commission Board. The Township Board reviewed this proposal and Christopher Dahm motioned to appoint Ron Zeiman to the vacancy, seconded by Tim Stefaniak. All in favor said aye. Motion carried.

Supervisor Barb Klasen presented the proposal from the Eagle Scout to the Board for his project called Possibilities Fair and Expo. The Project is a forum to provide information and fellowship on people with disabilities. The Board is asked to review the proposal and to make a donation to support the project. Supervisor Barb Klasen and the Board will make a donation in the amount of 50 dollars. This expo promotes the programs that are supported by the Township Board for people with disabilities and its seniors.

**Supervisor's Report:** Supervisor Barb Klasen presented a Levy recommendation to the Board for the Township and the Road District. The Levy will be presented next month for final review and approval.

**Road Commissioner's Report:** Highway Commissioner Don Goad not present.

**Bookkeeper's Report:** Bookkeeper Colleen Dumais reviewed the financials with the Board.

**Adjournment:** Tim Stefaniak motioned to adjourn the Township Board Meeting which was seconded by Charles Beard. Motion carried and meeting adjourned at 2016.
